Analysis Method: ATL-PLC-001

Following USDA guidelines on uncertainty, Accurate Test Lab uncertainty are calculated for CBDa and CBD at +/- 4%. The uncertainty for THCa and THC are +/- 5%. This implies the range for a 10% value of CBD to be 9.6-10.4%. The uncertainty range for a 0.30% value of THC would be 0.28-0.32%. The measurement uncertainty is calculated using a coverage factor of 2.

Reporting Limits will vary based on sample extraction weight used for the analysis. Accurate Test Lab, LLC utilizes based upon traceable Reference Standards and Certified Reference Material to calibrate analytical instruments along with proven analytical methods.
